Lease Administration

ALM’s experienced team of portfolio managers utilise an industry leading asset management software system to monitor the technical status and lease compliance of the aircraft portfolio. Lease administration activities include:

Day-to-Day Liaison with lessees

Invoicing of lease rentals and maintenance reserves and ensuring their payment in a timely manner

Monthly monitoring of utilisation and maintenance events

Monitoring of lessee compliance with registration, airworthiness and operational covenants







Management of maintenance reserves and End-of-Lease maintenance compensation

Ensuring lessee compliance with insurance requirements




Technical Monitoring

ALM's technical monitoring product is modular in concept so that the level of oversight can be tailored to fit the drafting of the lease and the characteristics of the lessee.

-  Audit of Lessee technical capability, systems, and procedures
-  Periodic inspection of aircraft, records and maintenance procedures
-  Monitoring of repairs and modifications, AD / SB status and tracking of rotatable component changes
-  Currency of aircraft certification, maintenance programme, manuals and technical record-keeping
-  Oversight of airframe and engine heavy maintenance
-  Analysis of maintenance invoices and reserve claims
